

Privacy Policy

The purpose of this Privacy Policy is to explain the principles on which your personal data is processed and to discuss your basic rights related to the processing of your personal data by us.

Personal Data Controller

The personal data controller is MOTOCONTROLLER sp. z o.o., headquartered in Krakow (KRS: 0000932185, REGON: 520440363, NIP: 6793226824, address: ul. płk. Dąbka 8/402, 30-732 Krakow). Personal data is processed based on the provisions of data protection laws, including Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons regarding the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) ("GDPR") and Polish regulations issued in connection with GDPR, including the Act of 10 May 2018 on the protection of personal data. The controller keeps personal data confidential and secures it against unauthorized access by third parties under the provisions of the above-mentioned legal acts. Scope and Purposes of Personal Data Processing

Within its activities, personal data is collected and processed:

- For purposes arising from the legitimate interests pursued by the personal data controller: to provide services to Clients, to market the controller's services, including informing about new products offered by the controller and its activities (e.g., within the newsletter), as well as for analytical, statistical purposes and to ensure IT security related to the controller's website (legal basis: art. 6(1)(f) GDPR);
- For the execution of contracts concluded by the controller with clients, to cooperate with suppliers and other entities cooperating with the controller (legal basis: art. 6(1)(b) GDPR);
- To conduct recruitment of persons interested in working or cooperating with the controller (legal basis: respectively art. 6(1)(c) and art. 6(1)(a) GDPR);
- To provide services to Clients, to market the services of the controller's partner, i.e., MS SELECT sp. z o.o., headquartered in Krakow, including informing about new products offered by the controller's partner and its activities, e.g., within the newsletter, email messages, phone calls (legal basis: art. 6(1)(a) GDPR);
- We also process personal data to fulfill the legal obligations imposed on the controller (legal basis: art. 6(1)(c) GDPR).

Your Rights

The processing of your personal data is based on voluntariness; however, depending on the circumstances, refusal to provide data or a request to delete it may prevent us, for example, from contacting you, providing you with information about the controller's activities, or performing a service. The processing of personal data within the provision of legal aid services is regulated in contracts concluded with clients or in general terms and conditions regarding the provision of legal services. The sending of commercial information electronically, e.g., via email, is conditioned on obtaining your prior consent, including by subscribing to the newsletter or by placing an order to receive certain information, including thematic legal alerts. Under the principles set out in legal provisions regarding data protection and within the scope provided therein, you have the right to access your personal data, the right to rectify, delete, or restrict processing, and the right to data

portability. Some of these rights may not apply to the processing of data within the provision of legal aid. If you do not want the controller to process your personal data for marketing purposes, you may object to the processing of personal data for this purpose at any time. Consent given for telephone and email contact for marketing purposes by the controller's partner can be withdrawn at any time. Right to Lodge a Complaint

You have the right to lodge a complaint regarding the processing of your personal data by the controller with the President of the Personal Data Protection Office (until the Act of 10 May 2018 on the protection of personal data comes into force – to the Inspector General for Personal Data Protection).

Processing Period

Personal data will be processed accordingly until the legitimate interests pursued by the data controller related to the processing of specific data are achieved, until the limitation periods related to the contract with which the data processing is associated expire, or related to the expiry of obligations under legal provisions until an objection is lodged concerning processing for marketing purposes. The newsletter and other similar information are sent until an objection in this regard is raised.

Sharing Personal Data with Other Entities

Recipients of your personal data may include entities directly or indirectly related to the controller, particularly in an organizational or personal manner, which would have their headquarters in one of the Member States of the European Union, as well as external service providers (e.g., the controller's partner, IT service providers, including cloud computing services, call center service providers, and marketing and promotional activities providers, other entities processing data on behalf of the controller based on a data processing agreement). Your personal data is processed at the controller's headquarters. Personal data is not transferred to countries outside the European Union. In the event of transferring personal data to third countries outside the EU, the controller will use appropriate instruments to ensure the security of your personal data. In connection with cooperation with its suppliers and other law firms, the controller may entrust the processing of your personal data to the above-mentioned entities. However, in each case, these entities will be obliged to maintain the confidentiality of your personal data and to process it in accordance with data protection regulations and the appropriate instructions of the controller.

Profiling

Your personal data will be subject to profiling as one of the forms of automated processing of personal data under art. 22(1) and (2) GDPR to prepare the best offer for you.

Changes to the Privacy Policy

Any changes made by us to the Privacy Policy in the future will be published on the controller's website, will apply only in the future, and will come into force after accepting the modified privacy policy, which you will be notified of through a pop-up window. If possible, we kindly ask you to regularly check our website for updates to our Privacy Policy. If you do not accept our Privacy Policy or the changes to the Privacy Policy, you should stop using our website.
